*RESOLVED, by the Board of Trustees of the Pacifica School District, County of San Mateo, State of California; that*

*WHEREAS, Matthew Levie assumed office on the Board of Trustees of the Pacifica School District serving 2 terms beginning in December 2012; and served in all roles on the Board including Board President for one year; and*

*WHEREAS, Mr. Levie's relationship with the District began as a parent at Vallemar School, he chaired a successful Parcel Tax Renewal campaign for Pacifica School District, increasing the amount to \$118 per parcel for five years bringing in 1.3 million dollars of revenue; he then, in November of 2012 ran for a seat on the school board; and*

*WHEREAS, Mr. Levie exemplifies fiscal responsibility and stewardship as he served Pacifica School District; Mr. Levie continued supporting another Parcel Tax Renewal that was successful in June 2016, bringing the Pacifica School District revenue for the next ten years; and*

*WHEREAS during his time on the Board, Mr. Levie reached an agreement for a benefits structure that helps to ensure the long-term health of the district; supported Pacifica School District through the implementation of state standards, adopting math curriculum that supports development of mathematical thinking and opportunities for success; spearheaded the vision of Workforce Housing to support retention and attraction of Pacifica School District employees; supported the implementation of a technology infrastructure plan to ensure robust connectivity and device allocation to compliment teaching and learning; supported Pacifica School District through the initial development and continued monitoring and enhancing of the Local Control Accountability Plan (LCAP) and Local Control Funding Formula (LCFF) budget; and*

*WHEREAS, Mr. Levie is and always was responsive to staff and community input, always willing to listen and to provide information to deepen one's understanding on the issue(s) and*

*WHEREAS, Mr. Levie's very thorough reading of Board Policy and Administrative Regulations provided insightful guidance alongside his fellow Trustees.; he focused on ensuring a strong educational program for all students- inclusive of the targeted student populations that Pacifica School District serves; represented Pacifica School District on Legislative Action Day multiple years to ensure local legislature understand the needs of the districts in San Mateo County;*
