



# Priority 1 Basic Services

Tool Used: School Accountability Report Card (SARC)

Objectives: **Appropriately Assigned Teachers, Access to Curriculum-Aligned Instructional Materials, and Safe, Clean and Functional School Facilities**

- 99% of teachers meet all credentialing requirements for their position
- 100% of students had access to their own copies of standards-aligned instructional materials (at school and at home)

# Priority 3 - Parent Engagement

Tool Used: **Parent Survey**

Objective: **Determine a baseline regarding parent perception of their level of decision making and participation at their child's school**

Analysis:

- 37% of families responded favorably to Family Engagement related questions in Spring 2017 which on these questions nationally
- Compared to all schools in a national data set this 37% favorable response was near the 80<sup>th</sup> percentile.
